NEFCC FALL GOLF CROQUET OPEN

Tournament October 15-17, 2021

This is a USCA sanctioned croquet tournament.

- Day one will be doubles 4-5 rounds to get familiar with the lawns. Partners will be assigned by tournament director to create competitive teams all in one flight. Competition will be single elimination and consolation play.
- Day two and three will be block play and then a Cup, Plate, Bowl, and Shield playoff. Players will be seeded in the knockout playoff by block play results. After the first two rounds of the playoff, players will then compete in one of the above four finals based on wins. Each player will play 5-7 rounds over 2 days until we have a winner for each group.

The tournament is sponsored by Northeast Florida Croquet Club, LLC promoting USCA tournament play in the Northeast Florida Region. The Ponte Vedra Croquet Club, Ponte Vedra, FL is hosting the tournament on its 7 lawns. Space will be limited to 28 players for golf croquet, so get your entry in early.

A practice area will be open at 7 am on Friday and Saturday before each day starts.
